## APPLICATION FOR DISCRETIONARY RATE RELIEF (DRR) – SECTION 47, LOCAL GOVERNMENT FINANCE ACT 1988

DRR: - The billing authority is empowered to award discretionary relief from rates, under the provisions of Section 47 of the Act, in respect of rates payable on properties solely used for charitable purposes. This relief may be in addition to any mandatory relief awarded to a body qualifying under Section 45.

Lewisham Council has limited budget for awarding discretionary rate relief and so restricts eligibility to certain organisations. Only organisations eligible for mandatory relief (80% relief funded by central government), can be awarded discretionary rate relief. Charity shops and cafes, housing associations, buildings used mainly for worship and bodies operating a restrictive membership policy are not eligible. The budget each year will determine how many applicants are awarded discretionary rate relief; with organisations with a lower rateable value being prioritised. Awards are for one year duration, and organisations must apply on an annual basis. Different arrangements are in place for schools and museums.
