Unit 1-3 Blackhorse Business Park, Blackhorse Road SE8 Demolition of existing building and the construction of a replacement building to provide flexible industrial and storage floorspace (Use Class B2/B8) and ancillary office floorspace with associated hard and soft landscaping, car and cycle parking and supporting infrastructure (DC/24/134840)
