**Applications affecting the setting of a Listed Building**

**Land at the rear of 179 Sandhurst Road and 174 Glenfarg Road, SE6**

Construction of 2 two semi-detached houses, together with the provision of amenity spaces and terraces, cycle spaces, bin stores, associated landscaping, and boundary treatment. The removal of the dropped kerb and associated repaving of the adjacent public footway fronting onto Torridon Road SE6 (DC/24/138501)

**Former Scout Hall/Hut St Swithun's Road SE13** Demolition of the existing former scout hall/hut and provision of 9 dwellings within a three-storey block (second floor in roof space) with associated private amenity spaces, landscaping works, cycle spaces and bin stores (DC/24/138517)

**5 Bromley Road SE6** Rear extension from first to third floor to create larger flats and associated works (Affects setting of locally listed building at 1 Bromley Road) (Please note amended description) (DC/24/138126)

**39 Tranquil Vale SE3** Alterations and conversion of the existing first floor restaurant to provide 1 self-contained flat, removal of existing outbuilding and construction of a single-storey rear extension to provide separate access to unit, repairs to the shop front, front & rear windows and roof, installation and alteration of rear-elevation windows, repositioning windows at first floor level & removal of the existing flue and ducts (DC/24/138222)
