# THE LONDON BOROUGH OF LEWISHAM (EROS HOUSE) ARTICLE 4 DIRECTION 1977

WHEREAS the Council of the London Borough of Lewisham being the local planning authority for the said Borough are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on the land shown edged red on the plan PD/4/77/ARTICLE 4 annexed hereto and known as Eros House, Brownhill Road, London, SE 6 unless permission therefor is granted on application made under the Town and Country Planning General Development Order 1977 (hereinafter called "the Order")

AND WHEREAS the Council is satisfied that the exercise of their powers under Article 4(3)(b) of the Order is necessary as the said development constitutes a threat to the amenities of their area

NOW THEREFORE the Council in pursuance of the powers conferred upon them by Article 4 of the Order (and in particular by Article 4(3)(b) thereof)

HEREBY DIRECT THAT

(1) The permission granted by Article 3 of the Order shall not apply

- 1) The permission granted by Article 3 of the Order shall not apply to any development on the said land of the description set out in the Schedule hereto
- (2) This Direction shall remain in force for six months from the date hereof and shall then expire unless it has been approved by the Secretary of State for the Environment before that date.
- (3) This Direction may be cited as "The London Borough of Lewisham

  (Eros House) Article 4 Direction 1977"


