1.0 Introduction

- 1.1 The River Corridor Improvement Plan Supplementary Planning Document provides guidance relating to the rivers and river corridors in the London Borough of Lewisham. This statement has been prepared under regulation 12 (a) of the Town and Country Planning (Local Planning) (England) Regulations 2012 to provide a summary of the consultation process relating to the Supplementary Planning Document.
- 1.2 Section 2 of this statement describes the main issues raised by those responding to consultation and explains how these issues have been addressed in the Supplementary Planning Document. Section 3 sets out the persons the local planning authority consulted when preparing the Supplementary Planning Document. A summary of the questionnaire responses is supplied in Appendix A and the consultation responses are provided in Appendix B.

1.3 Summary of Issues

- 1.4 The River Corridor Improvement Plan Supplementary Planning Document was made available for comment in line with the Town and Country Planning (Local Planning) (England) Regulations 2012.
- 1.5 The London Borough of Lewisham distributed a questionnaire via the Council's website, direct email and direct mail. Copies of the River Corridor Improvement Plan Supplementary Planning Document and the questionnaire were made available in Lewisham's libraries. The questionnaire responses are summarised in Appendix A.
- 1.6 A summary of the issues raised by the persons and organisations consulted, the Council's response and the actions arising is provided in the following table. The full consultation responses are included in Appendix B.
