EXECUTIVE SUMMARY

This report covers the financial year 2021-2022 which ran from 1st April 2021 to 31st March 2022.

It should be noted that when data is presented on developer contributions, that is the position at a point in time. The figures are always subject to change as sums are spent, allocated and received on a rolling basis. The data in this document is the most robust available at the time of its publication.

BACKGROUND

What is an IFS?

Local Authorities are required to report on an annual basis what they have received and spent through developer contributions and present them in an Infrastructure Funding Statement (IFS). As such this document fulfils the legal requirements which are set out in Schedule 2 of the Community Infrastructure Levy (Amendment) (England)(No.2) Regulations 2019.

This IFS:

- Contains information on the funding which has been generated by development within the borough for the financial year April 2021 March 2022.
- Notes the projects which have used developer contributions to fund the delivery of infrastructure during the reporting year.
- Reports on projects which were allocated developer contributions during that period, the use of Neighbourhood Community Infrastructure Levy (NCIL) and Borough Community Infrastructure Levy (BCIL).

What are developer contributions?

These consist of the sums agreed in s106 agreements (also known as 's106', 'section 106' or 'planning obligations') and the Community Infrastructure Levy (CIL). These are received by the Council from developers to mitigate the impact of development and to pay for infrastructure needed to support development.

What is Section 106?

Section 106 or planning obligations are legal agreements entered into to mitigate the impacts of a development proposal. They can be an agreement between the developer and the local planning authority or via a unilateral undertaking entered into without the local planning authority under Section 106 of the Town and Country Planning Act 1990 (as amended).

Planning obligations take the form of financial contributions and non-financial obligations. They are negotiated on a case-by-case basis, considering the individual site circumstances and the mitigation measures required for the development proposed. Planning applications will be refused where appropriate mitigation measures are not provided or cannot otherwise be secured.

What is the Community Infrastructure Levy (CIL)?

CIL is a charge per square metre that a Council collects on most new or existing developments that create a net additional 'gross internal area' of 100 square metres or more, or a development that creates a new dwelling regardless of the size of GIA. The charge per square metre depends on where the development is taking place and the use class. CIL came into effect on 6 April 2010 through the Community Infrastructure Levy Regulations 2010 (CIL Regs 2010).

CIL is a tool for Local Planning Authorities (LPA's) in England and Wales to help deliver infrastructure to support the development in their area, including transport, flood defenses, schools, hospitals and social care facilities. This includes the initial capital cost as well as operational and maintenance costs.

Regulation 59 of the CIL Regs 2010 restricts CIL and states:

"A charging authority must apply CIL to funding the provision, improvement, replacement, operation or maintenance of infrastructure to support the development of its area."

Section 216 of the Planning Act 2008 identifies 'infrastructure' by way of broad categories, which as amended excludes affordable housing.

CIL must be spent on infrastructure needed to support the development of the area, to provide new infrastructure, or, to increase the capacity of or repair existing infrastructure (if that is necessary to support development). Planning Policy Guidance (PPG) clarifies that whilst CIL can fund increases to the capacity of existing infrastructure or to repair failing existing infrastructure if that is necessary to support development, it is primarily intended to fund new infrastructure and not to remedy pre-existing deficiencies.

There is no requirement for the use of CIL funds to be directly linked to the development that pays it. It can be spent on infrastructure projects outside of the Borough's boundary, so long as it can be justified that it benefits Lewisham's residents. It can also be passed on to external infrastructure providers to spend and can be pooled between authorities to fund strategic projects. The Council can also reimburse expenditure already incurred on infrastructure or use CIL to repay money which it has borrowed to fund infrastructure.

Types of CIL

CIL is broken down into three types:

- Mayoral CIL (MCIL)
- Borough CIL (BCIL)
- Neighbourhood CIL (NCIL)

Mayoral CIL (MCIL)

MCIL applies to most new developments in London granted planning permission on or after 1 April 2012. It is collected by Local Planning Authorities on behalf of the Mayor of London.

In February 2019 the Mayor adopted a new charging schedule - MCIL2. MCIL2 charges took effect on 1 April 2019 (superseding the MCIL1 charging schedule) and applies to all planning permissions granted from that date and may apply to some phased planning permissions granted before.

MCIL raises money towards financing the Elizabeth line (Crossrail) with Crossrail 2 currently identified as the priority for future funding.

Borough CIL (BCIL)

BCIL is a charge applied to development to help fund strategic and neighbourhood infrastructure that is required to support the borough's development and growth. The current BCIL charges are £100 per sq metre¹ for residential (C3) uses in zone one, which covers the north of the borough; and outside this area, in zone 2, the charge is £70 per sq metre. For all other uses across the borough, excluding use class E, the charge is £80 per sq metre. Once received 5% is apportioned for the Council to spend on the administration of CIL.

On <u>24th July 2019</u> Full Council approved the strategy for the Neighbourhood CIL Process, following approval at Mayor and Cabinet on 4th June 2019. It was agreed that 25% of CIL would be apportioned to Neighbourhood CIL with the remaining 75% allocated as Strategic CIL. Administrative fees of 5% are removed from the total BCIL amount before apportioning NCIL or SCIL.

Neighbourhood CIL (NCIL)

NCIL is a portion of CIL to be spent on local priorities and it can be used to fund community projects that help offset the impact of development in the borough. NCIL is required to be spent in consultation with local communities.




Lewisham's Development Plan

Lewisham Core Strategy (2011)


This is the Council's principal planning policy document and provides the spatial context for new developments and regeneration initiatives as well as containing strategic site allocations. Lewisham's spatial strategy is contained this document which seeks to deliver at least 18,165 new homes between 2011 to 2026.





Development Management Local Plan (2014) Contains the Council's detailed planning policies.

Lewisham Town Centre Area Action Plan (2014) Sets out the vision, objectives, policies, and delivery plan for the regeneration of Lewisham Town Centre.

Site Allocations Local Plan (2013)

Allocates sites above 0.25ha which are likely to be developed between the lifetime of the plan (2011 – 2026).


Lewisham's new Local Plan

Lewisham's new <u>Local Plan</u> is at Regulation 19 Stage. The Regulation 18 document was published in early 2021 and consultation on the document ran for approximately 12 weeks from 15th January 2021 to 11th April 2021. The plan has been revised following the comments received and has been prepared for Reg 19 consultation beginning in early 2023.

The new plan sets out a shared vision for the future of the borough along with the planning and investment framework to deliver this vision through to 2040. It includes policies and guidelines used to determine planning applications (together with the London Plan, Grove Park Neighbourhood Plan, Crofton Park & Honor Oak Neighbourhood Plan, and any future neighbourhood plans). The new Local Plan will bring together the current suite of plan documents into a single document.

The plan sets out key strategic policies for the quantity and location of new homes, retail floorspace and workspace as well as transport and other infrastructure provision. It seeks to ensure that development is accompanied by the necessary infrastructure to develop high quality places where people want to live and work.

It also identifies the necessary infrastructure to accommodate this growth ranging from London wide strategic transport projects such as the Bakerloo Line Extension (BLE) or Lewisham based strategies including Reducing and Sustainably Managing Waste (policy SD12), Energy infrastructure (SD 4) and Safeguarding and securing community infrastructure (CI 1). It also sets out more localised infrastructure needs; for example, the need to support, enhance and protect a linear network of green infrastructure (LEA 4) in the 'East Area' part of the Borough.



The Infrastructure Delivery Plan (IDP)

The IDP seeks to identify the physical, social, and green infrastructure that may be needed over the local plan period and to ensure that the borough has sufficient schools, health centres, quality space, transport and physical infrastructure (e.g., utilities) it needs. It also seeks to supports the borough's environmental

objectives such as seeking to become a carbon neutral borough, tackling poor air quality, and greening the borough. It does not capture all the Borough's infrastructure requirements over the plan period; but focuses on strategic matters that underpin the delivery of the plan.

The Council undertakes ongoing infrastructure planning, by working with internal departments, residents, businesses, neighbourhood forums, and other community groups, associations and third parties (such as TfL, Network Rail and the Environment Agency), and reporting it in the IDP. New developments may also have additional needs for infrastructure and specific measures may also be needed. These are assessed on a case-by-case basis.

Infrastructure (for the purposes of the IDP) is the large-scale public services, systems and facilities that are necessary to support the social and economic activity of the borough. This includes public transport, roads, schools, power and water supplies, telecommunications, and GP practices. A wide range of strategic infrastructure projects will be required to support the level of planned growth within Lewisham over the long term.

The most recent version of the IDP was produced in September 2022 and it will be updated on a rolling basis.

Planning Obligations SPD



The Council published the <u>Lewisham Planning Obligations SPD</u> in February 2015. It sets out detailed guidance on the likely type and scale of planning obligations for development proposals to ensure that the impact of development on infrastructure and services can be adequately mitigated. It does not specify all planning obligations that may be necessary to mitigate the impacts of every development, as all sites have site specific or local circumstances.

This document seeks to establish a transparent, fair, and consistent process for negotiating, securing, and monitoring planning obligations.

Other key documents:

The Council's Corporate Strategy and Corporate Priorities:

The Council's Corporate Strategy (2022-2026) outlines the Council's vision for what will be delivered to residents over the next four years. These are:

- *Cleaner and greener* We will do everything we can to ensure that over the next four years we make the borough cleaner and greener for our residents. Working to tackle the climate crisis through every area of council policy, we will ensure Lewisham is rated as a 'top tier' council for our work on climate action.
- A strong local economy We will continue to expand our apprenticeship programme into new areas of work, building on the 260 apprentices that we placed during the 2018 –2022 administration
- *Quality Housing* We will deliver more social homes for Lewisham residents, working to provide as many people as possible with safe, comfortable accommodation that they can be proud of and happy living in.
- *Children and Young People* We will continue the fantastic work of the last four years, supporting our schools to improve and increasing the prospects of young people in Lewisham.
- Safer Communities We will work with the police to implement our new Violence Against Women and Girls strategy. This will include developing a new reporting tool that allows residents to map areas where they don't feel safe, and feed that back to the Council and police.
- *Open Lewisham* We will celebrate Lewisham's diversity, ensuring we are a representative and inclusive council and workforce.
- *Health and Wellbeing* We will partner with local food banks, food growing groups, schools, and communities, through our joint Lewisham Food Action Plan. Together, we will ensure that everyone can access food and other essentials



Lewisham's Infrastructure Priorities List

At a strategic level, the Council maintains a CIL Infrastructure Priorities list (formally known as the Regulation 123 List) which lists infrastructure which it intends will be, or may be, wholly or partly funded by CIL:

- State education facilities
- Public health care facilities
- Strategic transport enhancements (excluding site-specific, highways and public transport matters) needed to make developments acceptable in planning terms
- Publicly accessible open space, allotments, and biodiversity
- Strategic flood management infrastructure
- Publicly owned leisure facilities
- Local community (including (but not limited to) community centres and halls and libraries, but excluding places of worship)
- Public Emergency Services (this is intended to apply to physical projects by the police, fire, or ambulance services)

S106

Identification of projects and spend of s106

S106 agreements often secure financial contributions towards identified infrastructure needs (e.g. a local park enhancement) and /or address site specific mitigation measures (e.g. a highway alteration). When decisions are made on project spending the elements of the project must legally meet the specification defined within each S106 agreement. A list of all agreements is in Appendix 1.

S106 spend procedures

The procedures for allocating S106 funding were approved by Mayor and Cabinet in October 2003. This consisted of the establishment of a S106 Overview Group, a Project Initiation Document (PID) template and monitoring procedures. It also established the approval processes which are linked to spending thresholds:

- S106 Overview Group where the value is £40,000 or less;
- Regeneration and Capital Delivery Programme Board (RCPBD) for larger schemes with a value of between £40,000 and £499,999; and
- Mayor and Cabinet: where the value exceeds £500,000

Projects are given priority where they can clearly demonstrate that they:

- Address a need identified in the Infrastructure Delivery Plan;
- Deliver Lewisham's Corporate Strategy;
- Align with a departmental or service level strategy;
- Align with the Council's Corporate Priorities
- Address the Mayor's Manifesto Commitments

Projects must also offer value for money and meet the legal definitions specified within each S106 agreement. The funding of projects must consider using other funding streams alongside s106 where possible.

Applications to use s106 funds are put forward by the various Council departments, the National Health Service (NHS) and Transport for London (TfL).

Members of the public wishing to promote projects for S106 funding need to seek the support of officers appropriate to the delivery of the project. For example, for park improvements, project support needs to be sought from Lewisham's Environment Team and projects can only be delivered by a bona fide, properly constituted organisation.

During 2021-2022 reporting year, the Council received £3,759,577 in s106 monies and of the monies spent, none was spent by a third on behalf of the Council.

S106 monitoring fees can be spend outside the year that they are collected so if the amount spent can be greater than the amount received in a certain reporting year.

As the table on page 12 sets out, the total amount of s106 which was allocated for projects during 2021-2022 was £5,087,785. Of the money which was allocated in 2021-2022, £2,013,367 was spent on the projects which had received allocations during the 2021-2022 reporting year. When funds are allocated in projects each has its own timetable for spend according to several factors which include the scale of the project and when the sum needs to be spent by.

The total amount of s106 monies received before the start of the 2021-2022 financial year which has not been allocated by the end of the reporting year is £16,730,113.

S106 monies secured

In the reporting year 2021-2022, £3,730,635 was secured in legal agreements (Principal Deeds, Unilateral Undertakings and Deeds of Variation). The table below sets out a breakdown of the s106 monies which were secured during the reporting year 2021-2022.

The amount of s106 which the Council holds rises and falls as sums are spent and collected. S106 payments are received at different points (trigger points) during the life of a development, for example, some payments are received on signing of the s106, others on commencement of development, on occupation etc. Major and strategic schemes, which are usually phased, often make large payments over

the course of the development. This can mean payments being received many years after the development has commenced.

Non-financial planning obligations secured

For the year 2021-2022 various non-financial obligations were agreed, a detailed list is set out in Appendix 2. The list does not include additional school places, although improvements to facilities and provision were delivered in the reporting year. The key non-financial obligations are:

- 402 affordable housing units have been secured in s106s for delivery on site (0 provided off site) and 138 affordable student units
- 9 car clubs
- 5 financial review mechanisms


S106 allocations

At the end of the reporting year 2021-2022 the total amount of s106 monies allocated to projects was £21,144,011. During the reporting year 2021-2022 the total amount allocated to projects was £5,087,785. Of the amount allocated during 2021-2022, £2,013,367 was spent during 2021-2022. The amount that was not spent on projects where allocations were made during 2021-2022, was £3,074,419.

The chart below (Figure 1) shows the comparison for total allocations and spend between the current reporting year and the two years preceding it. The reporting year 2021-2022 saw the spend of s106 monies maintained at around £5.5m per year; with £5.4m spent in 2021-2022, with £5.9m spent during 2020-2021 and £5.7m spent in 2019-2020.

There was a fall in the allocation of funds by half from the previous year. This is due to several large allocations made for affordable housing and three significant park upgrades in 2020-2021. A detailed breakdown showing all allocations made during the year is set out in Appendix 3.





S106 spend

The total amount of s106 spent in 2021-2022 was £4,614,116. The next section sets out some examples of s106 spend for each service area during the 202-2022 reporting year (with a full list in Appendix 4):

Communities:

The Walk

£10,000 was spent on supporting The Walk. Good Chance, in collaboration with the Handspring Puppet Company, presented The Walk, which brought together artists, major cultural institutions, community groups and humanitarian organisations. This project brought Little Amal, a 3.5 m tall puppet of a young refugee girl, who represents all displaced children to Deptford on Friday 22 October 2021. She travelled over 8,000 km from the Turkey to the UK – sharing the urgent message "Don't forget about us".

Housing:

Wheelchair adaptions



£141,653 was spent on wheelchair adaptions, such as lifts and automated doors.

£75,000 was spent on a project to adapt properties across the borough and £66,313 on the adaption of three properties:

Leisure:

Wavelengths, Deptford

The overall investment was £449,000 on three projects which were completed in 2021-2022



£369,000 was spent on improvements to the leisure pool at Wavelengths Leisure Centre. The project included upgrades to the poolside changing village and improvements to the overall look and feel to the Leisure Pool Hall, removal of the flumes and upgrade of the pool plant.



£40,000 was spent on new access control turnstiles providing customers with a fast and efficient entry system into the leisure centre. They improve revenue protection, reduce ongoing maintenance costs, and allow concierge staff to fully focus on customers rather than access control operation.

£40,000 was spent on tiling refurbishment of the main 25m pool tank

Economy, Jobs, and Partnerships:

Youth Employment Support - Hardest to Help

£70,000 was invested over two stages in a project seeking to fill gaps in available employment support for "hardest to help" young people aged 18-24 in the borough. Intensive mentoring and coaching support is provided so that they can access training and employment, needs not being met by existing services in Lewisham.

Employment Support and Job Brokerage

£70,684 was used to support Lewisham residents into jobs, training, and apprenticeships, through activities including promotion of job and apprenticeship opportunities, advice and guidance on job applications, and coordination of local training programmes.

Local Labour and Business Team

£39,771.35 was spent to support the activity of the Local Labour and Business Scheme – which works with developers to secure non-financial employment, business and social value outcomes from Developers and their Contractors. This funding will help provide capacity to the team, to maintain key relationships and secure employment outcomes for local residents impacted by developments.

Town Centre Management across the borough

£34,624 was spent on the promotion of town centres through marketing and campaigns to encourage local shopping, such as the Shop Local campaign. This supports the Council's programme of actively promoting the growth of the local economy, which will create more local jobs and help to tackle unemployment and inequalities in the local labour market.



Covid-19 has had a significant impact on our high streets and town centres, with many businesses forced to close for periods of time which has meant they are encountering severe financial challenges and increased footfall and spending in local town centres will assist this.

Environment:

Greening Fund 1

A total of £578,851.83 was spent on the Greening Fund round 1

Tree Planting in Horniman Triangle

£3,105 was provided for the planting of 9 trees (6 hornbeams, 1 alder, 1 aspen, 1 beech) in Horniman Triangle. This funding was match funding required by the Forestry Commission's Local Authority Treescapes Fund to enable the project. The project provided a total of 195 trees which were planted in 5 parks in the borough during the 2021-22 tree planting season

COMMUNITY INFRASTRUCTURE LEVY (CIL)

History

Key dates in the history of CIL:

23 rd March 2010	CIL Regulations introduced
1 st April 2012	Mayor of London's CIL 1 implemented (MCIL1)
25 th February 2015	Lewisham CIL charging schedule and CIL infrastructure list (123 list) and Instalments Policy adopted
1 st April 2015	Lewisham CIL levied on all liable developments which have been granted planning permission in the borough
1 st April 2019	Mayor of London CIL 2 Implemented (MCIL2)

The Planning Act 2008 (as amended) and the CIL Regs 2010 (as amended) provide the powers for local planning authorities, or "charging authorities", to choose to develop and charge a CIL on development in their area.

The CIL Regs 2010 have been amended almost every year since they were first introduced in 2010.

Since CIL (Amendment)(England)(No.2) Regulations 2019 took effect in September 2019, the requirement for a Regulation 123 list (which set out CIL spending priorities) has been removed. Lifting the CIL Regulation 123 restriction gives more flexibility for councils to fund the same piece of infrastructure using both CIL and section 106 obligations, which was previously not allowed.

History of Lewisham CIL

August 2013	Community Infrastructure Levy (CIL) draft charging schedule submitted to the Planning Inspectorate.
15 October 2013	Examination In Public (EiP) held
25 February 2015	LBL CIL charging schedule and CIL infrastructure list (123 list) and instalments policy were adopted
1 April 2015	From this date, Lewisham CIL has been levied on all liable new developments granted in the borough. This is in addition to the MCIL.
2018	<u>Consultation exercise</u> undertaken as the first stage in the review of LBL CIL charging schedule. This work was paused to align it with the review of the <u>Local</u> <u>Plan</u> , although has not yet been restarted due to various factors.

Lewisham CIL charging schedule

Lewisham's CIL Charging Schedule was approved by the Full Council meeting on 25 February 2015 and came into effect on 1 April 2015.

Lewisham charge CIL on the net additional floorspace (gross internal area) of all new development apart from that exempt under Part 2 and Part 6 of the CIL Regs 2010. The amount to be charged for each development will be calculated in accordance with Regulation 40 of the CIL Regs 2010.



Once planning permission is granted, liability for the payment of CIL must be assumed before the development commences. The Council will then issue and serve a Liability Notice on the owner(s) of the land in question and any person who has assumed liability for the payment of CIL charge. The Liability Notice will also be registered as a local land charge. Payment is not required until commencement of development.

Mandatory relief from CIL is available in a few specific instances:

- A <u>charity landowner</u> where the chargeable development will be used wholly, or mainly for charitable purposes will benefit from full relief from their portion of the liability
- Where the development is a <u>self-build new home, extension, or residential annex</u>
- If the chargeable development comprises or is to comprise qualifying <u>social housing</u> (in whole or in part), the social housing element is eligible for relief from liability to pay CIL subject to conditions

CIL Collection 2021-2022

Total value of demand notices issued

To collect CIL, the Council send out Demand notices regarding developments. These are sent to those who assume liability to pay and after a Commencement Notice has been received. Demand Notices set out when the CIL needs to be paid and how much CIL is owed.

During the period 2021-2022 period 61 Demand Notices were issued. These notices had a value of £6,060,832. The total value from surcharges imposed due to breaches of the CIL Regulations is £47,568.83 and the total value of the late payment interest accrued is £10,507.

During the year 2021-2022 the Council collected £4,891,610 in BCIL receipts which was over 150% more than last year when £1,901,195 was collected. Of this amount £244,580 was retained for admin fees and £1,161,758 for NCIL.

In 2021-2022, the Council collected £2,863,333 in Mayoral CIL which is an increase of over 150% from last year, when £1,202,476.75 was collected.

Below is a chart showing the fluctuating nature of CIL income received by the Council.




Figure 4: Comparison on Borough CIL and MCIL collection for 2018-2022

Allocation of CIL

At the end of the reporting year £16,129,282 of CIL remained unallocated. This is the amount of CIL collected, not assigned for Neighbourhood CIL or CIL Administration, from 01 April 2015 to the end of the reported year that had not been spent.

Other CIL information

- Amount collected in Cash or as a Land Transaction (including payments in kind and infrastructure payments). Amount spent in the reporting year on items of infrastructure on which CIL (including land payments)

CIL Payments In-Kind

CIL Regulations 73(2010) (as amended), includes a provision that enables infrastructure to be provided by developers on development sites in lieu of a CIL monetary payment, should it be acceptable to the Council. There are benefits to receiving infrastructure as a payment as it may be more time and cost efficient to accept a completed piece of infrastructure from the liable party rather than the levy and it can also offer certainty over the timescale when certain pieces of infrastructure will be delivered.

NEIGHBOURHOOD CIL

The total amount of NCIL monies held at the end of the reporting year 2021-2022 is £5,376,427.

Overview of NCIL Process:

- <u>24th July 2019</u> Full Council approved the strategy for the Neighbourhood CIL Process
- The NCIL community funding programme was launched in August 2019. The borough pot 2015 2018 being £580,933.
- <u>11th March 2020</u> Mayor and Cabinet agreed the spending priorities for the borough wide allocation of the NCIL fund and agreed to allocate £100,000 of the fund specifically to projects relating to improving air quality.
- Early 2020 saw 17 out of 18 wards complete the priority setting stage which involved residents submitting ideas for priorities in their ward. Five or six priorities were then agreed at Ward Assemblies. Downham ward completed the priority setting exercise in Aug 2021 due to delays caused by the Covid pandemic.
- <u>10th March 2021</u> Mayor and Cabinet agreed a top up of £396,161 to the borough wide fund bringing the total available for Community Projects to £877,094 and an additional borough wide priority aiming to assist in Lewisham's Covid-19 recovery
- October and November 2021 Bids for projects were sought for Ward fund.
- <u>3rd November 2021</u> Mayor and Cabinet approved the allocation of NCIL Borough Wide funding to the list of recommended projects
- <u>9th March 2022</u> Mayor and Cabinet approved the allocation of NCIL Ward funding to the list of recommended projects

Spending priorities for the borough wide allocation

- Initiatives that seek to support local community groups to contributing to tackle crime and antisocial behavior
- Provision of high quality mentoring services and those designed to keep Lewisham's children and young people safe from exploitation, violence, and serious youth crime
- Support people with learning disabilities and/or issues with mental health to find employment opportunities
- Projects that assist Lewisham's COVID recovery

Lewisham's NCIL Strategy

Agreed distribution of NCIL:

Ward Fund - 50% to be retained by the ward where the development took place

Index of Multiple Deprivation (IMD) Pot - 25% redistributed across the wards using the indices of multiple deprivation

Borough Pot - 25% set aside for projects across borough




Figure 5: Chart detailing the breakdown of how Neighbourhood CIL currently spent within the borough

The Council have agreed to use 25% (rather than 15%) of CIL receipts for NCIL in order to for more meaningful local involvement and provide the community with sufficient resources to address the local impacts of development in a more comprehensive way.

NCIL Ward Fund

The NCIL Ward Fund amounts to £2,931,270. Each ward was given its own specific funding pot and agreed a set of local priorities, such as community projects, youth services, green spaces, community facilities and air quality.

Between December 2019 and March 2020 17 of the 18 wards within Lewisham (pre May 2022 boundary changes) ratified <u>5 or 6 local priorities</u> with an additional priority focusing on Covid-19 recovery. The Downham ward did not ratify their priorities until August 2021 due to delays caused by the Covid-19 pandemic.

The Open Call for projects stage was launched on 26 September 2021 and ran until 21 November 2021. A total of 250 applications seeking funding for just over £9 million were received and assessed by officers. The assessment of applications resulted in the allocation of NCIL ward funds valuing over £2.9 million to 152 projects across Lewisham's 18 wards. The Mayor and Cabinet report on the 152 approved projects can be accessed using this <u>link.</u>

Borough Wide Pot

On 11 March 2020, the spending priorities for the Borough Wide NCIL fund were agreed through Mayor and Cabinet.

The following was agreed:

• £100,000 to be allocated to the development of Council borough wide Air Quality initiatives that promote community involvement

That there would be an open call for projects that should meet the following priorities:

- Initiatives that seek to support local community groups to contributing to tackling crime and antisocial behaviour
- Provision of high-quality mentoring services and those designed to keep Lewisham's children and young people safe from exploitation, violence and serious youth crime
- Support for people with learning disabilities and/or issues with mental health to find employment opportunities
- To identify projects for which the remainder of the fund may be allocated
- Resolve that such funding should support services that are borough –wide, as far as possible, but provide extra focus on the most deprived wards in the borough as defined by the Indices of Multiple Deprivation

On 10th March 2021, Mayor and Cabinet approved an additional top up of £396,161 to the Borough Wide Pot, which brought the total amount in the pot to £977,094. The split of this sum being: £100,000 for Air Quality initiatives and £877,094 for allocation.

An additional priority was also agreed:

• Projects that will assist in Lewisham's Covid-19 recovery by demonstrating a benefit to Lewisham's communities at a borough wide level

On 28th May 2021, the open call for projects Borough Wide NCIL was launched; with the application process open until 25th July 2021.

During the open call for projects stage for the NCIL borough wide fund the council received 122 applications seeking £4.7m of NCIL funding. Of the 105 projects that successfully passed the due diligence requirements, officers agreed a final list of 25 recommended projects with a total value of £877,094 The Mayor and Cabinet report (Item no. 577 on the agenda) on the 25 approved projects can be accessed using this <u>link</u>.

Allocation of funding

GLOSSARY -

Infrastructure (for the purposes of the IDP)	is the large-scale public services, systems and facilities that are necessary to support the social and economic activity of the borough. It includes public transport, roads, schools, power and water supplies, telecommunications, and GP practices. A wide range of strategic infrastructure projects will be required to support the levels of planned growth within Lewisham over the long term
Infrastructure (indicative definition)	The indicative definition of Infrastructure is set out in the Planning Act 2008 and states that it includes: (a) roads and other transport facilities, (b) flood defences, (c) schools and other educational facilities, (d) medical facilities, (e) sporting and recreational facilities, and] (f) open spaces
Index of Multiple Deprivation	The Index of Multiple Deprivation, commonly known as the IMD, is the official measure of relative deprivation for small areas in England. It ranks every small area in England from 1 (most deprived area) to 32,844 (least deprived area).
