



**London Borough of Lewisham  
(Various Roads) (Lewisham People's Day)  
(Temporary prohibition of Traffic)  
Order 2022.**

**NOTICE IS HEREBY GIVEN** by the Council of the London Borough of Lewisham ('the Council') that, in order to facilitate the event known as "Lewisham People's Day" on and adjacent to the highway on various roads SE6 and SE13, in the said London borough, in exercise of powers conferred by section 16A of the Road Traffic Regulation Act 1984(a) and supplemented by powers conferred by section 287 of the Highways Act 1980(b) and of all other enabling powers, the following provisions of this Order shall have effect:-

1. The provisions of this Order shall come into force on the 16<sup>th</sup> day of July 2022 and shall remain in force for that day only.
2. Except as provided in articles 5 and 6 of this Order, no person shall cause or permit any vehicle to enter or proceed in:- (a) Carswell Road; (b) Ringstead Road; (c) Honley Road; (d) Farley Road; (e) Rosenthal Road; (f) Davenport Road; (g) Mountfield Close; (h) Woodland Street; (i) Redfern Road; (j) Laleham Road; (k) Blashford Road; (l) Benin Street; (j) The Woodlands; (k) Desvignes Drive; (l) Britton Close; (m) Stainton Road; (n) Blashford Street; (p) George Lane, between its junctions with Springrice Road and Hither Green Lane.
3. (1) Except as provided in articles 5 and 6 of this Order, no person shall cause or permit any vehicle to proceed in Stainton Road, between its junction with Mountfield Close and George Lane, in any other than a northerly direction. (2) The alternative routes for vehicular traffic affected by the prohibitions contained in articles 2 and 3 of this notice are via local neighbouring roads.
4. Except as provided in articles 5 and 6 of this Order, no person shall cause or permit any vehicle to wait for any purpose, including for the purpose of loading or unloading the vehicle or delivering or collecting goods, or otherwise remain stationary in: - (a) Carswell Road; (b) George Lane, both sides, between its junction with Fordyce Road and its junction with Hither Green Lane; (c) Hither Green Lane, both sides, between its junction with Springrice Road and its junction with Brightside Road; (d) Radford Road, both sides, between its junction with George Lane and its junction with Theodore Road; (e) Stainton Road; or (f) Desvignes Drive.
5. The provisions imposed by articles 2, 3 & 4 of this order shall apply only during such times and to such extent as may be indicated by traffic signs placed on the highway on behalf of the Council.
6. Nothing in articles 2, 3 & 4 of this order shall apply in relation to any vehicle being used for ambulance, fire authority or police purposes in an emergency or anything done with the permission or at the direction of a police constable in uniform and/or CSAS accredited stewards.
