Executive Summary

Every Health and Wellbeing Board must assess the need for pharmaceutical services in its area and publish a statement of this assessment¹. This is known as the Pharmaceutical Needs Assessment (PNA) and must be produced at least every three years.

In Lewisham the previous assessment was published in [March 2023](#). This was followed by a PNA Supplementary Statement in [November 2024](#), due to a number of pharmacies closing and several changes of ownership, which met the threshold to publish a supplementary statement, as per the statutory guidance.

As of September 2025, there are 48 pharmacies within Lewisham. This is fewer than in the last PNA, when they were 52. There are a further 31 pharmacies within 1km of the Lewisham borough boundary which also serve the Lewisham population.

For the purpose of this PNA, the borough was considered as four localities, mirroring the neighbourhoods as defined by the ICB's Integrated Neighbourhood Teams.

A PNA Steering Group was established in June 2025, which agreed the localities and the content of both the Public and Contractor consultation, as required by the statutory PNA guidance.

The PNA has found that overall provision of necessary (essential) pharmaceutical services in the borough is sufficient. There is a small area of the south-west of the borough which was identified as being more than 20 minutes walk to a Lewisham pharmacy, however there are Southwark pharmacies these residents can walk to within the same amount of time.

Whilst a pharmacy is open at some point on a Sunday in Localities 1, 2 and 3, there is no pharmacy open in Locality 4 on a Sunday. Having a pharmacy open in Locality 4 on a Sunday would improve pharmaceutical access for residents in the south-west of the borough, however as noted in the PNA, pharmacy opening hours themselves are not a pharmaceutical service.

In terms of advanced, enhanced and locally commissioned pharmaceutical services, which this PNA has deemed as those which improve accessibility and secure health improvements, the PNA has also determined that there is overall sufficient provision. There is a potential gap in Locality 1, as it is the only Locality that does not have a pharmacy offering the Smoking Cessation Service (for those continuing a stop smoking service which was started whilst a hospital in-patient).

Introduction

Background

It is a statutory requirement under the National Health Service (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013 for a Pharmaceutical Needs Assessment (PNA) to be developed and published every three years (or earlier where significant changes have occurred) by each area covered by a Health and Wellbeing Board (HWB). This publication schedule was paused during the COVID-19 pandemic. The last PNA in Lewisham was published in 2023, with a PNA Supplementary statement published in November 2024.

Purpose of the PNA

The purpose of the PNA is to plan for the commissioning of pharmaceutical services and to support the decision-making process in relation to new applications or change of premises or ownership of pharmacies.

As such, it is required to cover the following:

- what services are necessary to meet the needs of the local population
- which services have improved and/or have better access since the publication of the last PNA
- what provision is currently available, highlighting any immediate or future gaps in services
- any impact other NHS services have on pharmaceutical services
- how the assessment was carried out and the resulting conclusions

This information is held by NHSE/I to maintain a pharmaceutical list for the local area. This list is used to consider applications for new pharmacies as well as the relocation of existing pharmacies and to commission additional services.

The PNA bases its assessment on current and predicted demographics as well as analysing the health needs of the local population.

Scope of the PNA

The PNA covers community pharmacies included in the NHS Pharmaceutical List, dispensing doctors and dispensing appliance contractors. It does not cover pharmaceutical services in hospitals, prisons or online pharmacies (but must include Distance Selling Pharmacies which are included in the NHS Pharmaceutical List).

The minimum requirement for a PNA includes the following:

- a statement of the pharmaceutical services currently provided that are necessary to meet needs in the area
- a statement of pharmaceutical services that have been identified by the HWB that are needed in the area, and are not provided (gaps in provision)
- a statement of the other relevant services which are provided, which are not needed, but which have secured improvements or better access to pharmaceutical services in the area

- a statement of the services that the HWB has identified as not being provided, but which would, if they were to be provided, secure improvements or better access to pharmaceutical services in the area
- a statement of other NHS services provided by a local authority, the NHS Commissioning Board (NHSE/I), an Integrated Care Board (ICB) or an NHS Trust, which affect the needs for pharmaceutical services
- a map of providers of pharmaceutical services
- an explanation of how the assessment has been carried out (including how the consultation was carried out)
- The HWB must consult the bodies set out in Regulation 8 at least once during the process of developing PNA. The minimum consultation period required is 60 days.

Process for developing the PNA

A Steering Group of key stakeholders was set up to oversee the PNA process. Terms of Reference for the group are available at Appendix A - PNA Steering Group Terms of Reference.

The activities of the process and timescales are set out in the project timeline in Appendix B. This involved:

- updating information and evidence since the previous PNA, including latest priorities
- setting the scene for pharmacy services
- updating information on the population of and latest health information
- conducting surveys of pharmacies, of pharmacy users and of particular interest groups who may have specific needs
- preparing a draft for consultation
- Following this consultation, the comments will be assessed by the steering group and the final PNA will be published March 2026.

Localities for the purpose of the PNA

After changes to administrative boundaries, Lewisham shifted from having 18 electoral wards to 19, as of May 2022.

To define localities for the PNA, the PNA steering group elected to utilise the recently established neighbourhood health service in Lewisham (also known as Integrated Neighbourhood Teams).

The development of [integrated neighbourhood teams in Lewisham](#) has been informed by a range of engagement activity undertaken with partners, local communities and other stakeholders. A group of patients and residents with lived experience of health and care services, were recruited including those with a range of ages, religion, ethnicity, disabilities, and carer responsibilities. The group helped to gather insights and test ideas, shaping and refining our neighbourhood model based on real-life experiences.

What are the Localities/Neighbourhoods in Lewisham?

In Lewisham the four defined neighbourhoods for Integrated Neighbourhood Teams are:

Neighbourhood 1

Covers Evelyn, New Cross Gate, Deptford, Telegraph Hill, Brockley and also includes parts of: Crofton Park, Blackheath, Lewisham Central, Ladywell.

Neighbourhood 2

Covers Grove Park, Lee Green, and also includes parts of: Blackheath, Ladywell, Lewisham Central, Rushey Green, Hither Green.

Neighbourhood 3

Covers Bellingham, Catford South, Downham, also includes parts of: Hither Green, Rushey Green, Grove Park, Perry Vale.

Neighbourhood 4

Covers Forest Hill, Sydenham, also includes parts of: Crofton Park, Perry Vale, Bellingham.

As described above the Neighbourhoods do not map directly onto electoral wards, therefore a best fit approach has been taken for the PNA as described below.

PNA Context

National policies on pharmacy services

Legal framework for PNAs – the NHS Pharmaceutical and Local Pharmaceutical Services Regulations 2013

The National Health Service (Pharmaceutical and Local Pharmaceutical Services) Regulations 2013 set out PNA requirements (Part 2, Regulations 3–9).

In summary the 2013 regulations require that PNAs include the following:

- the pharmaceutical services that the Health and Wellbeing Board (HWB) has identified as services that are necessary to meet the pharmaceutical meet needs in the area.
- the pharmaceutical services that have been identified as services that are not provided but which the HWB is satisfied need to be provided to meet a current or future need for a range of pharmaceutical services or a specific pharmaceutical service (gaps in provision).

- the pharmaceutical services that the HWB has identified as not being necessary to meet the need for pharmaceutical services but have secured improvements or better access.
- the pharmaceutical services that have been identified as services that would secure improvements or better access to a range of pharmaceutical services or a specific pharmaceutical service, either now or in the future.
- other NHS services that affect the need for pharmaceutical services or a specific pharmaceutical service.
- how the HWB has determined the localities in its area.
- how it has considered the different needs of the different localities, and the different needs of those who share a protected characteristic
- an explanation of how the assessment has been carried out (including how the consultation was conducted).
- geospatial analysis of existing pharmaceutical service provision
- information on the demography of the area.
- whether there is sufficient choice for obtaining pharmaceutical services.
- the provision of pharmaceutical services in neighbouring HWB areas
- HWB must consult the bodies set out in Regulation 8 at least once during the process of developing PNA. The minimum consultation period required is 60 days.
- The Health and Wellbeing Board are also required to revise the PNA publication if they deem there to be significant changes in pharmaceutical services before the next publication is due.
- The structure and content of the report is based on 2025 guidance provided by the Department of Health and Social Care ([Pharmaceutical needs assessments: information pack for local authority health and wellbeing boards - GOV.UK](#))

Regulation updates

The NHS (Pharmaceutical and Local Pharmaceutical Services) (Amendment) Regulations 2023 updated the 2013 Regulations including changes allowing pharmacy contractors to apply to reduce their core opening hours of their 100-hour pharmacy to between 72 and 100 hours where certain requirements are met.

Since 1 April 2023 NHS England has delegated the commissioning of pharmaceutical services to the integrated care boards (ICBs). Therefore, each HWB should also ensure that the ICB or ICBs, for its area has, or have, access to its PNA and any supplementary statement.

From June 2025, pharmaceutical lists are prepared and maintained by the ICBs and published by NHS England as a consolidated list. This is commonly known as the NHS 'market entry' system.

The National Health Service Act 2006

Part 7 of the NHS Act 2006 applies to 'pharmaceutical services and local pharmaceutical services' and includes a description of pharmaceutical arrangements

that must be put in place within an area and the type of professional authorised to prescribe (Section 128A).

2021 White paper: People at the Heart of Care

The 2021 White paper sets out the legislative proposals for a health and care Bill, which promotes the establishment of integrated care systems (ICS) as statutory bodies in all parts of England. It lists ICSs as two parts – ICS NHS body (integration within the NHS) and ICS health and care partnership (integration between the NHS and local government). The White Paper includes the following themes: working together and supporting integration; reducing unnecessary bureaucracy; enhancing public confidence and accountability; and supporting public health, social care, and quality and safety.

Fit for the Future: 10 Year Health Plan for England

The NHS Long Term Plan (2019) has been superseded by the [Fit for the Future: 10 Year Health Plan for England](#) published in July 2025, which serves as the government's new guiding framework for transforming the NHS through shifts to prevention, community-based care, and digital technology, alongside workforce reforms and a new financial foundation.

The 10 Year Health Plan is part of the government's health mission to build a health service fit for the future. It sets out how the government will reinvent the NHS through 3 radical shifts:

- hospital to community
- analogue to digital
- sickness to prevention

To support the scale of change we need, the government will ensure the whole NHS is ready to deliver these 3 shifts at pace:

- through a new operating model
- by ushering in a new era of transparency
- by creating a new workforce model with staff genuinely aligned with the future direction of reform
- through a reshaped innovation strategy
- by taking a different approach to NHS finances

NHS Community Pharmacy Contractual Framework (the 'Pharmacy Contract')

The current Community Pharmacy Contractual Framework (CPCF) runs from 1st April 2024 to 31st March 2026. The most recent agreement focuses on services like the Pharmacy First service, which allows pharmacists to manage minor illnesses and urgent medicine supply.

The Pharmacy Integration Programme

The Pharmacy Integration Fund (PhIF) was introduced in 2016 and updated further to be in line with the NHS Long Term Plan. Currently, the Pharmacy Integration Programme is providing support to the following workstreams:

- Routine monitoring and supply of contraception in community pharmacy
- GP referral pathway and the NHS 111 referral pathway to Pharmacy First, which has three elements:
 - 7 Clinical Conditions
 - Minor Ailments
 - Urgent Supply
- Palliative Care and end of life medicines supply service.
- Structured medication reviews in PCNs for people with a learning disability, autism or both, linking with the STOMP programme.
- Expanding the existing New Medicines Service (NMS).
- Developing and testing peer and professional support networks for all pharmacists and pharmacy technicians working in PCNs.
- Exploring a national scheme for pharmacists and pharmacy technicians to gain access to essential medicines information resources working with SPS Medicines Information Services.
- Workforce development for pharmacy professionals in collaboration with Health Education England (HEE) including medicines optimisation in care homes, primary care pharmacy educational pathway, and integrated urgent care.

Local Context

Lewisham Joint Strategic Needs Assessment Review

The Joint Strategic Needs Assessment (JSNA) is a process by which the current and future health and wellbeing needs of the local population are described and considered. It exists to highlight inequalities between different groups of the population and aid commissioning and strategic decision making.

The [Lewisham JSNA](#) is held entirely online. It consists of a 'Picture of Lewisham' which describes the population of the borough in terms of the key health and socio-demographic characteristics, including mortality, morbidity, ethnicity and inequalities. This is supported by in-depth JSNA topic assessments which focus on a specific illness, population or subject, e.g. recently published examples include Immunisations and Children and Young People with Special Educational Needs.

The JSNA is reported up to the Health and Wellbeing Board.

Demography

As at the 2021 Census, Lewisham was the 14th largest London borough, in terms of population size and 6th largest in inner London. Lewisham has a young population

bias. Whilst the latest [ONS population projections](#) predict the borough's population will grow and is expected to reach just under 311,000 by 2030, this growth is not expected to be seen equally across age groups. Of note is the predicted school aged population cohort (5-14) will decrease by almost 6,000 by 2030. The predicted population growth is through a combination of the number of births exceeding the number of deaths and international migration, people moving to the borough from overseas.

The 2021 Census also states people from a White British ethnic group, comprise just over 37% of the population, Black African is the second largest ethnic group (12.6%) and 'White Other' (12.3%) and Black Caribbean (10.6%).

Spanish is the second largest nationality after British, with Nigerian the largest non-EU nationality (2021 Census).

Christianity remains the most stated religion or faith, however, fell by nearly 10% since the 2011 Census.

As detailed in the [LGBTQ+ JSNA](#), the 2021 Census was the first UK Census to ask questions on both sexual orientation and gender identity. In Lewisham approximately 6% of respondents stated their sexual orientation was other than straight or heterosexual (this is higher than both the regional and national averages). About 1% of the Lewisham 16+ population stated their gender identity was different to that assigned at birth.


Inequalities

Deprivation

The Index of Multiple Deprivation (IMD) is the official measure of relative deprivation for small areas (or neighbourhoods) in England. The IMD ranks every small area (Lower Super Output Area) in England from 1 (most deprived) to 33,755 (least deprived). For larger areas we can look at the proportion of LSOAs within the area that lie within each decile. Decile 1 represents the most deprived 10% of LSOAs in England while decile 10 shows the least deprived 10% of LSOAs².

The Index of Multiple Deprivation (IMD) combines information from seven domains to produce an overall relative measure of deprivation. The domains are Income; Employment; Education; Skills and Training; Health and Disability; Crime; Barriers to Housing Services; Living Environment. Each domain is given a weighting and is based on a basket of indicators.


Figure 2: Index of Multiple Deprivation - LSOAs by decile in Lewisham (2025)


Figure 3: Map of Index of Multiple Deprivation - LSOAs by decile in Lewisham (2025)

In terms of this overarching indicator, 20% of Lewisham LSOAs (or 1 in 5) are classified as the most deprived in England. When considered by locality, it is possible to see from Figure 3 (below) that there are pockets of deprivation in each of Lewisham’s four localities (darker the shading, the relatively more deprived).


Of relevance to the PNA is the Health Deprivation and Disability IMD domain. This has a slightly different distribution as shown in Figure 4 (below). Fewer Lewisham LSOAs are categorised as the most deprived in England, as 9.1% are categorised in Decile 1 and 2. Geographically there is less deprivation in Locality 1 in this domain (Figure 5).

Long-Term Conditions

Just under 15% of the Lewisham population are living with a long-term condition that limits their daily activities. This is a proxy question included in the Census to measure disability (2021 Census). Lewisham is slightly below the national average of 17.3%, but this is likely due to a younger population.

Unpaid Care

7.1% of Lewisham residents provide at least some unpaid care each week - about 20,000 people (2021 Census). People providing high levels of care are twice as likely to have poor health compared with those without caring responsibilities (Carers UK).

To make services increasingly equitable it is crucial to be aware of the inequalities that currently exist.

Children and Young People

- Lewisham is home to more than 70,600 people aged 0-19 (2021 Census).
- More than 15% of Lewisham children under 16 are categorised as [absolute low-income families](#) (OHID/DWP)
- [Pupil absence](#) is in-line with the rest of London and below the national average (OHID/DfE).
- [School readiness](#): 7 in 10 children are achieving a good level of development at the end of reception, above London and national averages (OHID/DfE)
- Rate of [first-time entrants to the youth justice system](#) has risen slightly but remains in-line with London and national averages (OHID/MoJ)
- 5.7% of 16 and 17-year-olds are not in education, employment or training ([NEET](#)) - this is above the London figure but in-line with the national average (OHID/DfE)


Older People

- The 2021 Census counted 28,700 Lewisham residents, aged 65 or older
- The rate of people aged 65+ [fracturing a hip due to a fall](#), was better than the national average (HES, 2023/24)
- The rate of Long-term support needs of adults (65+) met by admission to residential care per 100,000, is now higher than London and England (LG Inform, 2023/24).
- About 70% of people 65+ who have dementia are diagnosed - similar to London and national averages ([NHS Digital, 2024](#))

Life Expectancy


[Life expectancy](#) fell nationwide due to the Covid-19 pandemic, however the latest data has seen a small increase locally, regionally and nationally. For male residents in Lewisham, life expectancy remains significantly lower than the national average, with the gap remaining stable. However, for females in Lewisham, life expectancy is in-line with the national average (but below the London figure) (OHID/ONS).



Women in Lewisham live longer than men, but more years in poor health. This is also highlighted in Figure 8 (below), which presents premature mortality for both men and women, with males seeing much higher rates.



Healthy Lifestyle

Related indicators of note are:

- The proportion of [Reception aged children in Lewisham who carry excess weight](#) is slightly below the national average but slightly above the London average.
- For [children in Year 6](#) (last year of primary school), this proportion is significantly higher than both London and England (OHID/NHS England).
- In contrast, the latest figures show that [adults in Lewisham](#) are less likely to carry excess weight than the national average and are in line with the regional figure (OHID, based on Sport England data).
- Lewisham continues to have one of the highest [breastfeeding rates](#) in the country (OHID).
- Hospital admissions for alcohol related conditions in Lewisham are lower than England. For alcohol specific conditions, figures are in line with England (OHID/HES).
- More people in Lewisham [smoke](#) than the national average (OHID/NHSE).

Sexual Health

- The [teenage conception rate](#) (under 18s) has continued to fall and is now in line with the regional and national average (OHID/ONS).
- [Chlamydia](#) detection rate (under 25) remains higher than London and England (UKHSA)
- The rate of [new STI diagnoses](#) (excluding Chlamydia aged under 25) are significantly higher than London and England (UKHSA)
- [New HIV diagnosis rates](#) are higher than London and England, but overall numbers are relatively small. The rate of '[New HIV diagnoses among persons first diagnosed in the UK](#)' has fallen in the last year but remains higher than London and England (both UKHSA).

Lewisham Health and Wellbeing Strategy

Every local area's Health and Wellbeing Board is responsible for publishing a joint local health and wellbeing strategy (JLHWS), which sets out the priorities for improving the health and wellbeing of its local population and how the identified needs will be addressed, including addressing health inequalities, and which reflects the evidence of the JSNA.

Lewisham's Health and Wellbeing Strategy 2025-2030: *Prioritising prevention and acting on the social determinants of health* was published in 2025. The aim of the strategy is to improve the health and wellbeing of all Lewisham residents and reduce existing health inequalities by taking partnership action on prevention and priority social determinants of health for the borough.

The priority areas for action within the strategy are:

- Poverty
- Housing
- Education
- Prevention

The implementation of actions and monitoring of the strategy's impact will be overseen by the Lewisham Health and Wellbeing Board.



Public Health Outcomes Framework Review

The Public Health Outcomes Framework (PHOF) sets out a vision for Public Health. Its aim is to:

- improve and protect the nation's health
- improve the health of the poorest fastest

The framework focuses on the two high level outcomes for the public health system and beyond:

- Increased healthy life expectancy.
- Reduced differences in life expectancy and healthy life expectancy between communities.

The potential role of pharmacists in addressing local priority areas

The previous sections detail Lewisham's priorities as outlined in the JSNA and relevant strategies. We can also see where Lewisham is performing less well than the London average in key areas.

The potential role of pharmacists in addressing the key themes identified by the JSNA

As hospital admissions due to stroke have increased and are statistically significantly worse than the national average, there is a role of pharmacies to offer blood pressure monitoring, as well as potentially offer the NHS Health Check programme.

For both men and women in Lewisham, life expectancy is lower than the London average and for men it is significantly lower than the national average. Pharmacists have a role in promoting healthy lifestyle and prevention initiatives.

The potential role of pharmacists in addressing the key themes identified by the South East London Integrated Care System: Implementing the NHS Long Term Plan

Pharmacies are able to support the ICS objectives of:

- Early years by signing up to the Vitamin D scheme and delivery of certain childhood vaccines
- People with long-term conditions by monitoring, support, and treatment

Pharmacies tie into the prevention priority of both the Lewisham Health and Wellbeing Strategy and the South East London Integrated Care Strategic Priorities. Examples include immunisations, sexual health services, smoking cessation and potentially NHS Health Checks. Monitoring blood pressure and advanced Hypertension case finding service. Also supplying free Vitamin D.

Population

The latest population estimates are for 2024 (published in 2025). They estimate the Lewisham population is 301,255 (53% Female, 47% Male). Table 5 below highlights Lewisham's younger population bias. Only 10.3% of Lewisham's population is aged 65+, compared to 12.3% of London's and 18.7% of England's.



The north of the borough, particularly in Locality 1 has a much smaller population aged 65+. As health tends to deteriorate with age, this is likely to mean that certain pharmacy services could be less in demand in the areas with a smaller proportion of the population aged 65+. However, giving emphasis on healthy living and preventative care is relevant to all ages and deprivation is seen across the borough.

Table 6 (below) emphasises this point.

Population Density


Table 7 (below) shows the population density (people per Sq. Km) by locality and compared with London and England. The borough has a higher population density to London, but within the borough, the North (1) locality has more people per square kilometre than the other three localities. Bellingham ward has the lowest population density; however, it also includes the largest park in Lewisham. All figures are considerably above the England average which includes rural areas.



Table 8 (above) illustrates that for the borough of Lewisham, just over half of the population is from a White ethnic group. However, there is variation between localities, ranging from 59.2% of the population being from a White ethnic group in Locality 4 and 45.1% of the population in Locality 3. Lewisham has a much larger proportion of its population from Black ethnic groups than both London and England. It has a lower proportion of the population from an Asian ethnic group than London but in line with England.

Population Projections

Lewisham housing trajectory and planning

The latest Lewisham authority monitoring report (2022-23), states that there were:

- 455 net new self-contained homes (464 new homes completed and a loss of nine existing homes)
- 32 net new non-self-contained units

This constitutes about half the amount that is usually built, considering the annual average of 1,017 per year, over the last 10 years. The completed self-contained housing has been delivered on a range of sites. They include 256 homes (56%) on 10 major sites (10 or more units):

- 55 new homes in Creekside (Deptford ward)
- 45 new homes in Rushey Green (Rushey Green ward)
- 33 new homes in Sydenham Road (Sydenham Gate ward)
- 26 new homes in Haulage Yard, Hereford Place (Deptford ward)
- 23 new homes in Somerville Estate, 2-27 Wellington Close (Telegraph Hill ward)
- 20 new homes in The Haven and Betuna, Grove Park Road (Grove Park ward)
- 17 new homes in Northwest Garages, Knapdale Close (Forest Hill ward)
- 14 new homes in Rutland House, Rutland Walk (Perry Vale ward)
- 12 new homes in Myron Place (Blackheath Gate ward)
- 11 new homes adjacent to Brasted Close (Sydenham ward)

There are also 75 small sites (less than 10 units) which account for 199 (44%) of the net self-contained completions.

If implemented, approvals made during 2022-23, will result in a minimum net gain of 254 self-contained new homes and 39 non-self-contained units. This does not meet the 1,667 annual target in the 2021 adopted London Plan.

The approved new homes will be delivered on a range of sites across the borough. They include: 95 new homes (37%) on 4 major sites (10 or more units):

- 35 new homes in New Cross Road (Telegraph Hill ward)
- 24 new homes in Farmstead (Bellingham ward)
- 21 new homes in Eastdown Park (Lee Green ward)
- 15 new homes in Hesper House, Wells Park Road (Forest Hill ward)

There are also 159 new homes (63%) on 64 small sites (9 units or below).

Whilst population growth is expected in Lewisham the PNA has demonstrated that there is sufficient capacity within Lewisham pharmacies to absorb this expected growth. In terms of transport whilst growth will be experienced across the Borough, this will not significantly change the pattern of local traffic and therefore access to services will remain the same. Lewisham HWB will monitor pharmacy service provision in the areas of development and expected population growth.

Considering differences in demand for Pharmaceutical Services by Locality

Whilst the north of the borough, particularly Locality one sees greater ethnic diversity and an overall younger population profile, the 2021 Census has highlighted that Lewisham's population continues to diversify. There is an older population bias in Localities 3 and 4, which might increase demand for pharmaceutical services, however these localities are less densely populated than Locality 1.

The recent publication of the IMD data in 2025, shows that there remain areas of deprivation across each of the borough's four localities.

Pharmaceutical service provision within Lewisham

This section describes the current provision of pharmaceutical services to Lewisham residents. The aim is to identify any existing or potential gaps in services by looking at location of pharmacies, opening hours and the different level of provision.

Community Pharmacies

In September 2025 there were 48 community pharmacies in Lewisham, which equates to 15.9 community pharmacies per 100,000 residents (based on a 2024 ONS mid yearly estimates). This ratio is below the London (19.9) and England (18.9) averages respectively.

There are 31 pharmacies within 1km of Lewisham's borough boundary.

There are no Distance Selling Pharmacies or local pharmaceutical services (LPS) providers in Lewisham. There is one 100 Hour Pharmacy.

Figure 15: Pharmacies within a 1km walk of the Lewisham Borough Boundary




Figure 16: Lewisham GP Practices by ward and locality and University Hospital Lewisham

Figure 17: Map of Drug and Alcohol Addiction Treatment Services within Lewisham




Needle and Syringe exchange services are available at 55 Dartmouth Road.

Full details of pharmacy opening hours are available in Appendix C. All Lewisham pharmacies are open Monday - Friday. There are 39 Lewisham pharmacies which open for at least part of Saturday and 5 pharmacies which open at least part of Sunday.

Pharmacy Opening Hours

Under NHS Community Pharmacy contracts, core opening hours are contractually set at either 40 or 72 hours per week, depending on the type of contract held. Any additional hours, referred to as supplementary hours, are not mandated by the NHS


and fall outside the scope of commissioned pharmaceutical services. These hours are offered at the discretion of the pharmacy contractor and while they can improve patient access, they are delivered at the contractor's own financial risk. Pharmacy opening hours themselves are not classified as a pharmaceutical service.

Travel Time to a Pharmacy

Walking


Figure 19: 20 minutes walking time to a Lewisham Pharmacy

The vast majority of locations in Lewisham are within a 20 minute walk of a Lewisham pharmacy (areas highlighted in pale yellow in Figure 19 below). There is a small area of the North West of the borough, in Locality 1, a larger area in the South West of the borough in Locality 4 which are more than 20 minutes walking distance from a Lewisham pharmacy. There is also an area in the South East of the borough (Locality 3), which is more than a 20 minute walk to a Lewisham pharmacy. The section at the centre south of the borough is within Beckenham Place Park and not residential. The SHAPE Tool estimates that less than 1% of the Lewisham population cannot walk to a Lewisham pharmacy within 20 minutes.

Figure 20: 20 minutes walking time to any pharmacy from a Lewisham location



Car

All areas of Lewisham can reach a Lewisham pharmacy within 10 minutes travel by car, even when allowing for rush hour traffic, as modelled by the SHAPE tool.

Pharmaceutical Services provide by Lewisham Pharmacies

Community pharmacies must provide at least essential services and then the below listed pharmaceutical services are optional:

- Advanced services - optional NHS nationally commissioned services that pharmacies can provide if they meet the specified requirements
- Enhanced services
- Locally commissioned services

Pharmacy owners (contractors) must provide essential services, but they can choose whether they wish to provide advanced and enhanced services (as well as locally commissioned services).

Essential service provision commissioned from community pharmacies

The essential services (sometimes called necessary services) are the core services that all pharmacy contractors must offer as specified by the NHS Community Pharmacy Contractual Framework (CPCF). They are:

Dispensing

The safe supply of medicines or appliances. Advice is given to the patient about the medicines being dispensed and how to use them. Records are kept of all medicines dispensed and significant advice provided, referrals and interventions made.

Repeat dispensing

The management of repeat medication for up to one year, in partnership with the patient and prescriber. The patient will return to the pharmacy for repeat supplies, without first having to visit the GP surgery. Before each supply the pharmacy will ascertain the patient's need for a repeat supply of a particular medicine.

Disposal of unwanted medicines

Pharmacies accept unwanted medicines from individuals. The medicines are then safely disposed of.

Discharge Medicines Service (DMS)

This is a relatively new essential service that pharmacies must provide, with the aim of better communication of changes to a patient's medication when they leave hospital or other care setting and to reduce incidences of avoidable harm caused by medicines. If successful it reduces hospital re-admissions.

Healthy Living Pharmacies

This service aims to improve public health by providing accessible health promotion interventions and wellbeing services and helping to reduce inequalities. It aligns with the promotion of healthy lifestyle which is a core requirement for all community pharmacies.

Promotion of Healthy Lifestyles (Public Health)

Opportunistic one to one advice is given on healthy lifestyle topics, such as stopping smoking, to certain patient groups who present prescriptions for dispensing.


Provision of Essential Pharmaceutical Services in Lewisham

Whilst the number of community pharmacies in Lewisham has fallen from 52 in the previous PNA to the current 48, overall, there remains sufficient pharmaceutical provision in the borough. This is due to the relatively small geographical size of the borough and the numerous options for pharmaceutical provision within 1km of the borough boundary.

Pharmacy Locations compared to Population Density

As highlighted earlier in the document, population density varies notably across the borough. Figure 22 (below), maps population density by ward and Lewisham pharmacy locations. Whilst pharmacies are not evenly spaced across the borough, the most densely populated areas do see more concentration of pharmacies. Locations also tend to be focused in areas of higher footfall, such as town centres.

Advanced Services

Advanced Pharmaceutical Services are those services that pharmacies may choose to provide if they meet the required standards. These services go beyond essential pharmacy services, offering targeted support to improve patient outcomes, enhance public health, and reduce pressure on other parts of the healthcare system.

Information on these standards and the services themselves are set out in the Pharmaceutical Services (Advanced and Enhanced Services) (England) Directions 2013 which can be found in [Part VIC of the Drug Tariff](#).

As at May 2025, there are eight advanced services that pharmacies may choose to provide.

Six of the advanced services are:

- New Medicine Service
- Community pharmacy seasonal influenza vaccination service
- NHS community pharmacy hypertension case-finding service
- NHS pharmacy contraception service
- NHS lateral flow device tests supply service
- NHS Pharmacy First

There are also two appliance advanced services that pharmacies may choose to provide:

- Appliance Use Reviews
- Stoma Appliance Customisation

Provision of Advanced Services in Lewisham

New Medicine Service

The NHS New Medicine Service allows community pharmacists to provide structured support to patients and carers about their medication for a range of conditions and promote lifestyle changes or other non-pharmacological interventions to enhance well-being.

All Lewisham pharmacies provide this service, therefore there is sufficient provision of this service.

Community Pharmacy Seasonal Influenza Vaccination Service


As part of the overall NHS effort to improve flu vaccine uptake rates and reduce pressure on services, community pharmacies can choose to offer a flu vaccine service. This aids the health and social care system manage winter pressures by helping to reduce demand for GP consultations and likelihood of hospitalisation.

This service is available in 34 Lewisham pharmacies for adults. Details in Figure 23 and Table 14 below. Due to the wide distribution of pharmacies offering this advanced service, there is sufficient provision in Lewisham overall. Residents in Locality 2 have the greatest choice of provider within their locality, with residents in Locality 3 having the least choice of provider.

Figure 23: Lewisham Pharmacies offering flu vaccines to adults





Table 15 (below) shows which Lewisham pharmacies provide a flu vaccine service to pre-school age children. Provision across the borough is sufficient and there are at least three providers in each locality. However, provision is not spread equally across the borough, e.g. residents in Locality 2 have a choice of eight providers, whilst residents in Locality 1 have only three providers.

Hypertension Case-Finding Service (Blood Pressure Check Service)

Hypertension is the biggest risk factor for cardiovascular disease (CVD) and is one of the top five risk factors for all premature death and disability in England. An estimated 5.5 million people have undiagnosed hypertension across the country³. CVD is also a key driver of health inequalities, accounting for around 25% of the life expectancy gap (27% in men and 24% in women) between rich and poor populations in England. Those in the most deprived 10% of the population are almost twice as likely to die because of CVD than those in the least deprived 10% of the population. Therefore, this advanced pharmaceutical service is a key tool in both diagnosis and prevention.

Only one Lewisham pharmacy does not offer this service, therefore there is sufficient overall provision, including in relatively more deprived areas of the borough. This is particularly beneficial to the Lewisham population, as highlighted earlier in the PNA, that residents see higher rates of stroke and under 75 mortality due to cardiovascular disease.

Pharmacy Contraception Service

The Pharmacy Contraceptive Service began in April 2023 to allow for continued supply of oral contraception from community pharmacies and from 1st December 2023 included both initiation and on-going supply of oral contraceptives. The aim of this service is to offer greater choice and access to those considering starting or continuing their current form of oral contraception. This forms part of the Community Pharmacy Contractual framework (CPCF) and seeks to reduce the pressure on GPs and sexual health clinics. The service allows for self-referral as well as referral by general practice, sexual health clinics and other NHS service providers such as NHS 111 to a participating pharmacy.

All Lewisham pharmacies are providing this service, therefore there is sufficient provision. The service has been further updated from Oct 2025 to also include EHC.

NHS Lateral Flow Device (LFD) Tests Supply Service

The LFD tests supply service is an Advanced pharmaceutical service. It is available for eligible people, who are at risk of becoming seriously ill if they contract COVID-19, so that they have tests at home, ahead of any potential COVID-19 virus symptoms. This will then allow people to test promptly and act as necessary.


38 of 48 Lewisham pharmacies provide this service. At least seven pharmacies in each locality offer this service, therefore provision by locality is also sufficient.

Pharmacy First

The Pharmacy First service commenced on the 31/01/24, replacing the Community Pharmacy Consultation Service (CPCS) which ended on the 30/01/24. It comprises three elements.

Element 1 of this Advanced service involves pharmacists providing advice and NHS-funded treatment, where clinically appropriate, for seven common conditions (age restrictions apply):

- Sinusitis (12 years and over)
- Sore throat (5 years and over)
- Acute otitis media - infection of the middle ear (1-17)
- Infected insect bite
- Impetigo (1 year and over)
- Shingles (18 years and over)
- 'Uncomplicated' UTI (Women aged 16-64)

Consultations for these seven clinical pathways can be provided to patients presenting to the pharmacy as well as those referred electronically by NHS 111, general practices and others.

Element 2 is Minor Illness consultations, which requires a GP referral. Element 3 is Urgent Medical Supply.

All Lewisham's Pharmacies provide this advanced service, therefore there is sufficient provision overall and across each locality.

Enhanced Services

Enhanced Services are a further tier of pharmaceutical services and like Advanced Services are optional for pharmacies to offer. Pharmacies can be commissioned to provide an Enhanced Service from either NHS England; the local ICB or the Council (Public Health).



Figure 26: Lewisham Pharmacies offering COVID-19 vaccines to adults



Vitamin D


The Department of Health's Healthy Start scheme helps pregnant women and children under four in low-income families eat healthily through the provision of breastfeeding and nutrition support including free food and vitamin vouchers. The scheme provides vitamin supplements through arrangements with local community

pharmacies. In Lewisham as an extension to Healthy Start all pregnant women and children under 4 regardless of income can access Vitamin D supplements free of charge. Supervised consumption for opiate substitution therapy


Community pharmacies can choose to offer supervised consumption of opioid substitution treatment to reduce risk of overdose and non-compliance with treatment.

Needle exchange


Needle exchange is an enhanced pharmaceutical service whereby pharmacies supply needles, syringes and other equipment used to prepare and take illicit drugs. The aim is to reduce the transmission of hepatitis B and C and other blood-borne viruses or other infections caused by sharing needles.

This service is available in 9 Lewisham pharmacies. Whilst this provision is sufficient to serve the borough overall, it should be noted that in localities 3 and 4, there is only one pharmacy offering this enhanced service. However in Locality 4, this service is also available at the Lewisham Primary Care Recovery Service on Dartmouth Road.

Smoking Cessation

Smoking is directly linked to numerous health conditions and is a significant contributor to premature mortality. The advanced pharmaceutical service of Smoking Cessation is specific to people who commenced a stop smoking programme in hospital and have been referred to a pharmacy (when discharged from hospital) to continue their stop smoking programme.

19 pharmacies in Lewisham have expressed an interest in providing smoking cessation services, however at time of writing this PNA, there are currently three Lewisham pharmacies providing this service.

It was highlighted earlier in the PNA that Lewisham sees a higher proportion of people smoking during pregnancy than the London average. Whilst Lewisham has a well-established Stop Smoking Service, delivered by Lewisham and Greenwich Trust, smoking cessation services in pharmacies is a potential area that could be considered to widen provision to make it more accessible. It should also be highlighted that there is no pharmacy in Locality 1 providing this service.

Stakeholder Engagement

Overview

PNA Guidance states that both service users (the public) and pharmacy contractors should be consulted to inform the draft PNA. This should be done through a questionnaire uploaded to an online platform. Questions for both questionnaires were discussed and decided at the first meeting of the Lewisham PNA Steering Group. The aim was to gain feedback from both key professional stakeholders and communities on local pharmacy services.

Public Questionnaire

The PNA regulations state that a public questionnaire must form part of the consultation process for a PNA. This should be uploaded onto an online platform for at least four weeks. In addition to following the relevant guidance, as pharmacies are an important asset within local communities offering several NHS services, it is crucial to get service user feedback to inform this needs assessment. Public involvement in commissioning enables residents to voice their views, needs and wishes, and to contribute to plans, proposals, and decisions about the services available in their local communities.

Public Survey: have your say on pharmacy services

The 2026 Lewisham PNA Survey was open from 08/08/2025 - 26/09/2025. The design of the public survey was approved by the PNA steering group. The Public Survey was available online via the council's consultation tool – Citizen Space, which is linked to the Council's website and promoted by the Public Health Communications Officer to residents and services users. The full survey questions are available in Appendix D.

95 participants completed the survey, all of whom were Lewisham residents. Most respondents were female (79%). There was a clear age basis as over a third of respondents aged were between 65-74 years old (35%) and approximately a quarter were between 55-64 years old (26%). Although this is disproportionate to the borough's population, pharmacy services users will have a bias towards older ages.

Of the respondents 80% identified themselves as White British. Nearly half (45%) of the respondents considered themselves to have a disability or long term.

The survey findings were as follows:

- The majority (96%) of the respondents use a pharmacy in Lewisham. Using a pharmacy a few times a month was the most common usage by the respondents (40%).
- Most of the respondents said they use the local pharmacy to collect prescribed medication (97%). Many used their local pharmacy to buy medication that does not need a prescription (over the counter medicines) (54%) and for advice (35%).

- The reasons for other pharmacy use were for flu and COVID vaccinations (67%), repeat prescriptions for long term conditions (13%) and blood pressure reading.
- The majority of the respondents use the same pharmacy on a regular basis (73%).
- Most of the respondents usually walk to their pharmacy (77%), and it takes no more than 10 minutes (63%).
- A quarter of the respondents said there is a more convenient or closer pharmacy that they do not use (26%).
- On weekdays, mornings (47%) and afternoons (25%) were the most convenient time for respondents to access a pharmacy.
- For Saturdays, mornings (56%) and afternoons 17% were the most convenient time for respondents to access a pharmacy.
- Mornings (32%) and afternoons (15%) were also the most convenient time for respondents to access a pharmacy on a Sunday,
- Overall, respondents were less likely to express a preference for visiting the pharmacy at the weekend, with 18% not answering the question relating to Saturday and 44% not answering the question relating to Sunday.
- Most respondents (85%) were satisfied or very satisfied with the pharmacy opening times.
- Of the 63% of respondents who used them, 41% were satisfied or very satisfied with the consultation rooms.
- Many respondents (74%) used the pharmacy for a medicines review or advice and 60% were satisfied or very satisfied.

Comments Respondents Had About Pharmacy Service Provision

Describing access issues

I can access this pharmacy myself on my good days. On bad days I can with difficulty access sometimes. I have peripheral neuropathy in my feet which makes walking difficult. If I am suffering from fatigue, it takes me longer to walk (and do everything else!).

I am sometimes able, and sometimes unable, as my health/disability varies from day to day...I believe this is an issue for many people with disabilities.

Why don't you use nearest pharmacy?

I have used the same pharmacy for over 30 years and feel no need to change. Very helpful pharmacist and staff.

I use two pharmacies - one is adjacent to my son's GP but not near my house since I moved last year from Ladywell to Catford and is particularly good at sourcing ADHD medication and managing changes to prescriptions. The other is near to my home for convenience for less complex prescriptions.

Other services you would like

A knowledge hub of other allied groups in the area for things. Making the pharmacy a social place for the community. Currently neither the pharmacy nor library have a list of all the available support in the local area for different conditions or social groups.

I am really happy with this pharmacy. They are very lucky to have such an excellent, caring pharmacist in charge of this particular one. He runs a really good pharmacy; despite the difficulties he must encounter with recruitment of decent staff and other demands.

Minor ailments management and medical solutions. Weight management support

I would like my local pharmacy to be able to cope with private prescriptions, which it was unable to do when I was let down by the NHS, who suddenly stopped prescribing medication I'd been on for 5 years

Other reasons dissatisfied with the pharmacy opening hours

Although they close at 6 on a weekday, most of our local pharmacies close at midday on a Saturday. None near us are open on Sundays. We really miss having one inside the Sainsbury's Savacentre. Our nearest pharmacy open on Sunday is in Hither Green and not easily accessed by bus so I have to drive to get there.

The pharmacy should be open until 7pm during the week, instead they close at 6pm. So, they should be open more hours. And on Saturday they close at 1pm so people that work on Saturday morning cannot get any service.

No evening or weekend hours. Small pharmacy so medication often not in stock and needs to be ordered if prescription hits on a Thurs, this could mean it's not available til Monday afternoon. Ok for regular medicines, but not for emergency/one-off...leaves me having to find alternative.

Other reasons dissatisfied with consultation room

Tiny, and glass...no privacy

Not very private as you can hear people in there with the door shut and is right near the counter.

It is a very small cubicle with no natural light or ventilation. I feel very sorry for the pharmacist.

Better use of pharmacies

As previously stated, the pharmacy(ies) could become more of a community hub, having lists of local support services/groups and also (and this may help with youth employment choices) hold talks as to what a pharmacist does in a hospital/community situation and the career pathway. So many people think they are just in a shop, when in fact it is a STEM related career path.

Alcohol and substance misuse clinics available in their consultation room, using a qualified professional rather than this being from the GP.
Travel health advice and vaccinations available

Maybe a nurse on site a few days a week, to address minor wounds or answer questions that a pharmacist is not sure about, but doesn't necessarily need a GP appointment, especially with babies/young children

Ensure each clearly advertises the services that it offers in the window
If the pharmacy is closed, indicate where such services can be obtained (e.g. Saturday pm and Sunday)
Recycling of blister packs
More pharmacies to offer a travel vaccination service

I honestly don't know but if you do introduce new things don't just add it onto their existing workloads. Increase their staff and their pay to take this work on.

Pharmacy/Contractor Survey

The Lewisham Pharmacy Contractor Survey was conducted to inform the PNA. The survey was developed considering questions asked in previous PNA processes and with input from the steering group to ensure that changes in the pharmacy system since 2022 were reflected in the questionnaire. The survey covered the full range of topic areas relating to the development of community pharmacies. The full questionnaire is available in Appendix E. The online survey was hosted on the council's consultation tool, Citizen's Space, but with access restricted to those issued the relevant link.

All Lewisham pharmacies were invited to take part, this was done by the Community Pharmacy South East London, as this approach was considered to maximise uptake. The survey was open between 08/08/2025 - 26/09/2025, with follow up email reminders sent to pharmacies to request they respond. These dates included an additional three weeks to optimise the response rate.

At the time of survey, there were 46 pharmacies in Lewisham. A total of 16 pharmacies completed the survey, giving an overall response rate of 35%.

Out of the 16 pharmacies that completed the survey, 4 (25%) were from locality 1 (North), 4 (25%) were from locality 2 (Central/South), 5 (31%) were from locality 3 (East), and 3 (19%) were from locality 4 (West).

Four wards had no pharmacies respond: Bellingham, New Cross Gate, Ladywell and Sydenham. Hither Green ward had two pharmacies respond.

Of the pharmacies that responded two, (in locality 4) close for lunch on Saturdays, but none closed for lunch on weekdays. Three pharmacies close on Saturdays, two in locality 1 and one in locality 2. One pharmacy in locality 1 opens on Sundays.

There were no distance selling pharmacies.

Accessibility/facilities

- All pharmacies reported being within walking distance of a bus stop. The majority (88%) reported a bus stop within 50m of the pharmacy. The remaining pharmacies (12%) reported a bus stop between 100m and 400m from the pharmacy.
- The majority of pharmacies (69%) have dedicated disabled (blue badge) parking within the vicinity and an entrance suitable for unaided wheelchair access. All areas of the pharmacy floor accessible by wheelchair at all pharmacies and over half have wheelchair ramp access (56%). A quarter of pharmacies have a front door bell accessible to a wheelchair user. One pharmacy has automatic door assistance.
- More than half of pharmacies have large print labels/leaflets (56%). A small number of pharmacies have handrails (13%), a hearing loop (13%) and a removable wheelchair ramp (6%). None of the pharmacies who responded

have a disabled toilet facility. One pharmacy has no other facilities aimed at helping disabled people access their services.

- There is a reasonably good provision of, and access to pharmaceutical services for those with physical and mobility impairments in Lewisham.

Consultation facilities

- Nearly all pharmacies (94%) have wheelchair accessible consultation rooms. Under a quarter (19%) of pharmacies have toilets that patients can access for screening or for patients attending consultations. There are hand washing facilities in, or close to the majority (88%) of consultation rooms. In all pharmacies the consultation rooms have either a computer or laptop and an A4 printer.
- A third of pharmacies (31%) undertake consultations and/or offer services in patient's homes or other suitable sites.

Pharmacist availability

- Of the pharmacies that responded three (19%) normally have two or more pharmacists on duty at any time during the week, each working between 20 and 30 plus hours per week.

Staff languages spoken

- At 12 pharmacies (88%) there were regular staff fluent in a language other than English. In addition to English there were a total of 26 different languages spoken. The most popular languages were Gujarati (50%), Hindi (44%) followed by Swahili and Urdu (both 19%).
- There is a good provision of and access to pharmaceutical services for those with English as second language in Lewisham. The presence of staff fluent in 26 languages beyond English highlights the sector's ability to meet the needs of Lewisham's diverse communities.

Services

- The majority of pharmacies (88%) dispense a variety of appliances. These include catheters (88%), compression garments (88%), incontinence products (69%), stoma bags (56%) and wound dressings (88%).

Advanced services

- Many of the pharmacies (63%) provide free home delivery of dispensed medicines 19% with a charge, in some cases this service is limited to housebound patients and local areas.

Other services

- Many pharmacies provide additional services either privately and/or under contract with ICB, Local Authority or NHS England.
- A wide variety of services are provided including Alcohol Screening and Brief Intervention, Antiviral Distribution Service for Influenza, Body Weight Assessment, Health Coaching, Chlamydia Testing and Chlamydia Treatment, Emergency Contraception, Expanded Incontinence Service, Gluten Free Food Supply and Head Lice Eradication.

Independent prescribing service or patient group directions service

- The majority of community pharmacies provide patient group directions services or under contract with the ICB, Local Authority or NHS England. A smaller minority provide independent prescribing and patient groups directions privately.
- More than half of pharmacies are willing to provide more services if commissioned and a small amount (6%-13%) were not able or not willing to provide.
- One pharmacy provides the following additional services: private ear infection services, private back pain services, private period delay and private chicken pox vaccination services.

Medicines optimisation service

- As part of the medicine's optimisation service 41% of pharmacists who responded were willing to provide additional services if commissioned.
- A small proportion of pharmacists provided services under contract with the local NHS England Team (4%) or with the ICB or Local Authority (4%).
- A little over a quarter of pharmacist were not able or not willing to provide additional services.

Statutory Consultation on Draft Lewisham PNA 2026-2029

The statutory consultation on the Draft Lewisham PNA 2026-2029 was open for the mandated 60 day period (31/12/2025 to 28/02/2026), via the Lewisham Consultation Portal (Citizen Space). 33 responses were received.

The key themes from the responses to this element of consultation were:

- Lack of pharmacy availability due to closure of pharmacies and/or population growth in Bellingham, Forest Hill and Lee Green.
- Several respondents stated that they felt that not enough consideration had been given to pharmacies users who had accessibility needs, when considering travel times, either on foot or via public transport
- Lack of 'Out of Hours' access to pharmacies, i.e., after 5pm on weekdays and at the weekends was raised by many respondents to this element of the consultation

All feedback on technical and operational issues, i.e. amending opening hours have been incorporated into the final document.

Conclusions and Statements

In conclusion this PNA has shown that despite the decrease in the number of pharmacies across the borough, since the last PNA, there remains sufficient pharmaceutical provision for residents during the most common working hours of 9am-5pm. Current access to **essential** pharmaceutical services therefore meets residents' needs.

Whilst the Lewisham population is projected to grow both during the lifetime of this PNA and beyond, it is not anticipated that this would overburden the current pharmacies, who it is anticipated could absorb any additional capacity of current planned new housing developments.

In terms of advanced and enhanced pharmaceutical services, which improve accessibility and secure health improvements, overall provision also continues to be sufficient. As highlighted earlier in the document there is not currently a pharmacy in Locality 1 offering smoking cessation support (to those who have started a stop smoking service prior to hospital discharge), which would benefit this population.

5. Other aspects of the process as appropriate

Roles and functions of the steering group

The Lewisham PNA Steering Group has been established to:

- Oversee and drive the formal process required for the development of a PNA for Lewisham
- Ensure that the published PNA complies with all the requirements set out under the Regulations
- Promote integration of the PNA with other strategies and plans including the Joint Health and Wellbeing Strategy, the Integrated Care Board (ICB)'s Commissioning Strategy Plans and other relevant strategies.

Key Objectives

- Support the work to develop the PNA with internal and external stakeholders, including patients, service users and the public
- Approve the project plan and timeline
- Ensure that the requirements for the development and content of PNAs are followed and that the appropriate assessments are undertaken, in line with the Regulations
- Determine the localities which will be used for the basis of the assessment
- Determine the criteria for necessary and relevant services and apply these to pharmaceutical services, taking into account stakeholder feedback including views from patients and the public
- Oversee the consultation ensuring that this meets the requirements set out in the Regulations
- Submit the final PNA to the Health & Wellbeing Board for approval prior to publication
